Acute Potential Health Effects: Skin: Causes skin irritation. Eyes: Causes eye irritation. Ingestion: May cause irritation of the gastrointestinal tract with generalized discomfort, diarrhea, nausea, vomiting abdominal pain. With ingestion of large doses of ammonium acetate, there arises the possibility of sufficient absorption to produce diuresis and systemic ammonia poisoning. May also affect behavior/central nervous system (tremor, anxiety, impairment of motor performance or recognition, flaccidity of facial muscles) and respiratory system (dyspnea). Inhalation: Dust can irritate the respiratory tract (nose, throat, lungs) with symptoms of coughing, wheezing, and/or shortness of breath. Chronic Potential Health Effects: Ingestion: May cause some liver dysfunction, and may affect the brain, behavior/central nervous system with symptoms similar to that of acute ingestion. Inhalation: Repeated exposure can irritate the lungs. It may also cause bronchitis to develop with cough, phlegm, and/or shortness of breath.
